Cancellations: Written cancellation requests must be received by AHLA no later than **February 10, 2027**. Approved refunds — less a \$200 administrative fee — are issued roughly 3–4 weeks after the conference, in the original form of payment. No refunds are issued for cancellations submitted after this date.

Substitutions: A one-time substitution may be made in writing up to 2 business days before the event. Because rates are tied to the attendee's AHLA membership status, a non-member substitute for a member-discounted registration will be charged the fee difference.
