Process of a Speaking Proposal

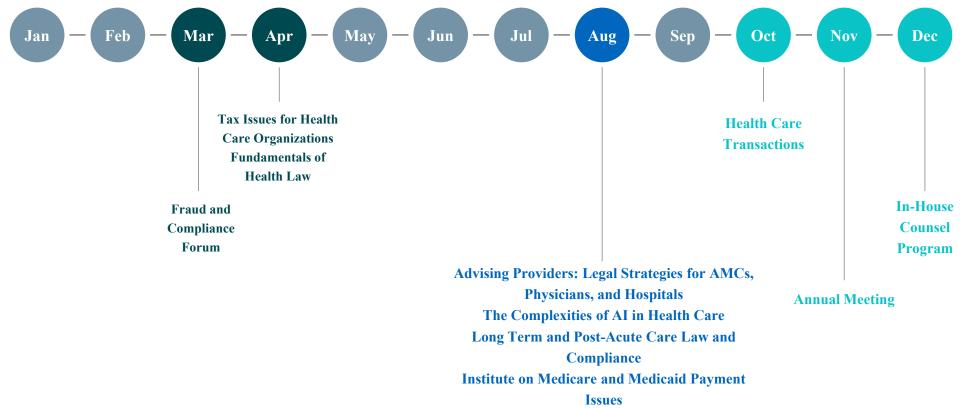

Building Your Proposal

AHLA Speaker Policies

- No more than 2 speakers from the same firm/organization on the conference
- O Do not allow 2 speakers from the same firm/organization on the same session.

Your Topic Idea

- Review the previous year's agenda
- What are the challenges the industry is dealing with, and how can you help solve them?
- Not Too Niche, but Not Too Broad

Title and Bullet Points

- Keep the titles focus on what it is about.
- Keep it to 4-6 bullet points tell them what you're covering.

Co-Speakers

- Keep panels to 4 or fewer. Sessions are 60 or 75 minutes.
- Keep in mind differing prospectives and professional settings (in-house counsel, law firm, compliance officer, consultant)

Session Level

 Most sessions hit the "intermediate" level of audience knowledge, but we accept topics that hit all levels, basic (primer), intermediate, and advanced

• Presentation Style

 Teach learn vs interactive panel vs small group/case study approach

Committee Review

Committee Review

- First Round Review. Second Round Review.
- Proposal can be chosen as is.
- Similar proposals are grouped and reviewed together to evaluate
- Proposals can be combined
- Speaker from one proposal can be added to another proposal
- Time in the review process may vary based on the number of proposals we receive. It could take 3-4 months from when the proposal is submitted until you hear one way or the other.

Proposal Decision

Proposal Decision

- You and your co-speakers will hear one way or the other.
- Committee outreach starts as soon as the agenda is finalized.
- AHLA conference staff will then take over speaker management communication on topic, deadline dates, logistics, etc.
- Reimbursement Benefits:
 - All speakers receive a complimentary registration to the conference
 - o Incidentals (the allowance is based on the length of the conference)
 - O Hotel and travel for those who are *in-house counsel, compliance officers, academicians, or government representatives*. We do not cover hotel and travel for those in private practice or consulting firms. The number of hotel nights covered depends on the length of the conference.
